This Memorandum of Understanding (here in after called as the 'MOU') is entered in too 30. DAY of March Two Thousand and Twenty Two by and between






### Clause 1



### SCOPE OF THE MOU

#### Clause 4

##### VALIDITY

#### Clause 5

##### CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

#### Clause 6


##### MANAGEMENT

## Clause 8

### CONFIDENTIALITY


During the tenure of the MoU both IGCE and Unique MEP Engineering Academy Pvt. Ltd., will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MoU for any purpose other than in accordance with this MoU.

Both IGCE and Unique MEP Engineering Academy Pvt.Ltd., shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of either parties or use such confidential information for any use other than intended purpose under this agreement.

Further both IGCE and Unique MEP Engineering Academy Pvt. Ltd., shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

Confidential Information shall mean any proprietary information, data or facts belonging to Parties collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:

- a) Is or becomes publicly available through no fault of the receiving party;
- b) Is already in the rightful possession of the receiving party prior to its receipt of such data or information;
- c) Is independently developed by the receiving party without reference to the confidential information of the disclosing party;
- d) Is rightfully obtained by the receiving party from a third party or is in the public domain;
- e) Is disclosed with the written consent of the party whose information it is, or Is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.

2. After this Agreement has been signed, all preceding understandings/negotiations and correspondence pertaining to it shall become null and void.


