

- Bizme Aalytix will not be responsible for loss/theft or damage of any of the student's belongings. IGCE should instruct their students clearly on the precautionary measures.
- 7. The implementation of specific activities will be separately agreed between both institutions on need basis.
- 8. Other terms and conditions which are not provided in this Agreement will be deliberated and agreed upon by the institutions here to.
- ThisAgreementisestablishedinEnglishlanguageandisvalidfromthedateof signing by the representatives of the institutions. The institutions hereto have executed this Agreement in duplicate, and each institution shall keep one copy of the originals.
- 10. This agreement shall be governed by and construed in accordance with the laws of India.
