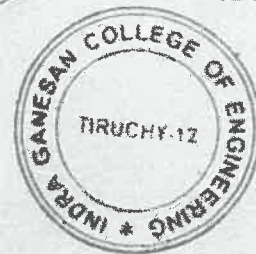
WHEREAS:

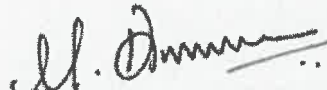

General information about the college

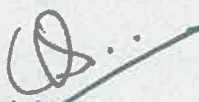

1. Siemens CoE offers various skill development courses across different disciplines. IGCE committed /commits to send 50 number of students /faculty every year for such courses. The timing /duration of the courses shall be arrived on mutually agreed dates. The CoE offers 20-40% discount on the regular advertised course fee depending on the demand.
2. A student /faculty who has completed any CoE offered courses will be given 10 hours of free Lab usage time after the course within one-year duration. The timing will be decided by the CoE based on the availability.
3. Siemens CoE offers the resources for student projects on chargeable basis. It is the responsibility of the faculty mentor from IGCE to monitor the progress. The CoE shall not offer any certification for such usage but shall provide an attendance certificate.
4. Siemens CoE offers Internships to students. The CoE can accommodate a reasonable number of students depending on the demand.
5. The faculty of IGCE shall submit funding/consultancy proposals quoting the Siemens CoE resources. In such cases, a NITT faculty will be the Co-PI and budgeting need to be arrived through mutual discussion before submission.

11. Other terms and conditions which are not provided in this Agreement will be deliberated and agreed upon by the institutions hereto.

15. This agreement shall be valid for a period of three years from the date both signatures are affixed to this document or before if terminated by mutual agreement of both. This agreement may be terminated by either party after one hundred and twenty (120) days following receipt of a written notification of intent to terminate by the other party.
16. If a proposal to renew this agreement is not presented before the end validity period, it will be terminated automatically at the end of three years.

PREAMBLE

This Memorandum of Understanding (MoU) is signed on 13 September 2019 and valid till 15th September 2021 between SASTRA Deemed to-be University Tirumalaisamudam, Thanjavur, 612487 (hereafter referred to as SASTRA MENTOR HUB Institute) represented by the Registrar and Indra Ganesan College of Engineering, Madurai Main Road (NH-45B), Manikandam, Thiruchirappalli - 620012, hereafter referred to as Mentor/SPOC.E Institution represented by the Director/Principal for the purpose of mentoring mentee institutes to guide and disperse knowledge and encourage best practices in technical institutions by extending services provided to faculties and students, under the Margdarshan Scheme of AICTE, New Delhi.

1. Nature of Relationship

- 1.1. This MoU is for collaboration between both Hub and Spoke institutes, for mutual benefit in many purposes set out as given below to enhance quality educational experience for faculty, and students.
- 1.2. This MoU shall be valid for three years from the date of signing, and each party shall be at full liberty to terminate the collaboration, with a notice period of 3 months.
- 1.3. Both parties shall take all reasonable steps to ensure the successful completion of the collaboration and co-operate with each other in duly carrying out the obligation as agreed upon.

2. Objectives of Collaboration

- 2.1 To organise Faculty Development Programme (FDP) – on the latest technologies and need based topics under AICTE -Margdarshan Scheme for faculty of mentee institutes over three years by SASTRA / Mentor Institute.
- 2.2 To organise Guest Lectures – containing identified areas of interest of the SPOKE institutions by Mentor Institute to the students of the mentee institutions.
- 2.3 To enable Research Interaction between the HUB & SPOKE institutions by SASTRA for faculties of mentee institutes under AICTE -Margdarshan Scheme for three years through workshops and interactive sessions.
 - 2.3.1 To do joint publications arising out of collaborative work.
- 2.4 To enable the mentee institutions to equip themselves to apply for ~~ABBA~~ accreditation by the above academic interventions and support from mentor institute.

3. Nature of Relationship

3.1.4 Both parties shall maintain confidentiality about any information, course material, plans, discussions, strategies or any material, which shall be deemed to be confidential and marked accordingly. Any information, course material or the like in the public domain shall not be part of this commitment.

3.2 Limitation and Warranties

3.2.1 Each party shall ensure that the other is not to put to any liability for any act of the respective party.

3.2.2 Each party represents that they have the full power and authority to enter into this MoU in general.

6.3 Both parties will designate a representative(SPOC – single point of contact) from its side, who will be the primary point of contact on behalf of that party for coordination purpose.
